JUDGMENT.

An application to decide and certify the Boundaries of the Land
of Napaa District of Puna Island of
Hawaii having been filed with me on the 1 day of October
1872 by J. O. Nomina Commissioner of Crown
Lands

in accordance with the provisions of an Act to facilitate the settlement of Boundaries, &c., approved on the 22d day of June, A. D. 1868; now, therefore, having duly received and heard all the testimony offered in reference to the said boundaries and having gone on the said land, at the request of J. M. Mahalena acting for Crown Commissioner and having endeavored otherwise to obtain all information possible to enable me to arrive at a just decision, which will more fully appear by reference to the records of this matter by me kept in Book No. 1, page 26, 28, and it appearing to my satisfaction that the true, lawful and equitable boundaries, are as follows, viz:

Commencing on the sea shore adjoining Waipouli at Maluapalepo, Thence to a spot on Kula near Government Road called Kahua-kahua, Thence to commencement of large Acacia Mahabakupanahi, Thence along aduwai to Pohakuhivana Thence to a stone in indigo Kaumehewa Thence to a stone called Pohu-pohuikai, Thence along ridge to Hulumoa Thence to Ouakii near hau trees. Thence past hau clump across stream to Ridge

Kalouulew, Thence to tops of Ridge Hinaike,
makani, Thence to former site of Houses Pene
Thence to new bush Hauiki. Thence to stream
Kaukahokew, Thence across stream to Kauai-
holana, Thence to Kapuhaili where houses for-
merly were, Thence to a little mound, called
Kainamane, Thence to Kahilimalanai junction
with Olohena and Waipouli, Thence up and
along ridge to tops of mountain ridge called
Kapehukola where there is a water fall
and Thence along tops of mountain ridge from
peak to peak to Makalehu, and Thence con-
tinuing on mountain ridge to a high sharp
rocky peak called Pihakupili the junction
of Kapoa with Kealia and thence following
down the Kealia Boundary as rectified by
the Boundary Commissioner on the 5th day of
December 1870 to the sea.

It is therefore adjudged and I do
hereby decide and certify that the Boundaries
of the said land are and hereafter shall be as
hereinbefore set forth.

Notes of Survey of Southern Boundary of Kapaa, commencing at sea beach at a place called Kaleapalepa from whence the following objects bear Anahouka S 65° 40' W Nord S 82° 52' W Anahouka spoke N 6° 41' W thence from beach on the following bearings and distances

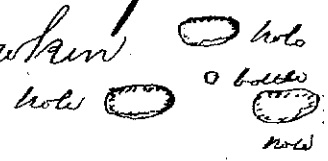
- 67° 44' W ^{319.0} 5444 to Hoaka 3 stones lit into ground close to road way.

to a large Ohia tree at the head of Waipouli and junction of Kapa'a and Oloheua and known by the name of Kahilimalawai, thence on up a ridge to Kapehuola (see plan) thence on round the top of mountain range to Maskaletu and round to spur leading down to Pohakipuli a prominent and well defined point (see plan)

at all the stations on the survey three large holes have been dug, and in the centre of them a bottle set into the ground and broken
