JUDGMENT.

An application to decide and certify the Boundaries of the Land
of Lawai District of Kooloa Island of
Kauai having been filed with me on the 8 day of July
1873 by J. O. Dominis Attorney in fact for
Luun Dowager Emma,

in accordance with the provisions of an Act to facilitate the settlement of Boundaries, &c., approved on the 22d day of June, A. D. 1868; now, therefore, having duly received and heard all the testimony offered in reference to the said boundaries and having gone on the said land, at the request of James W. Gay acting on behalf of J. O. Dominis and having endeavored otherwise to obtain all information possible to enable me to arrive at a just decision, which will more fully appear by reference to the records of this matter by me kept in Book No. 1, page 58, and it appearing to my satisfaction that the true, lawful and equitable boundaries, are as follows, viz:

Commencing on the sea beach
at a point called Manalou and thence
running Maueka across a gully and point
of rocks to a place called Luawahinopileu
Thence to a large pile of stones called Ma-
kaulii; Thence to top of ridge called Kapu-
hikama. Thence down side of hill to a rock
called Upoupo. Thence crossing stream and
along foot of spur. to side of stream called
Hali'opai Thence to a large stone called
Hali'opai, situated between two streams

Thence up a narrow ridge to two stones set into
the ground, Thence to Wamalewaa, Thence
spanning near a large hole called Kakainaha,
Thence to Haleana, Thence along ridge across
gully up and along top of ridge, Thence down
side of hill crossing gully and on to spur,
Thence crossing gully to spur called Kapana
Thence to Pihaki and on to a large rock called
Leho, Thence to another rock called Leho
Thence crossing stream and through clump
of trees to side of grass spur, running down
from bush, Thence crossing gully and up
side of range to a saddle or low part in
main ridge, and thence to a peak called
Punakolo and thence down along the Kolow
Boundary in all its turnings and windings
to the sea

It is therefore adjudged and I do hereby
decide and certify that the Boundaries of the
said land are and hereafter shall be as
heretofore set forth

The South West Boundary of this Land commences
at the sea beach at a point called Kanaalooa and joining
the South East corner of Kalaheo and runs thence

The Eastern Boundary of this land commences at a point on the sea shore at a sand stone rock on the west side of Kukuia harbor and runs thence

- V 28° 0' N 2648 " to a red hill to the west of Cepe stream
- V 20° 12' N 7275 " to a stone set into the ground on the south side of a large hole called Kapeleua

 in a hole close to a road
- $\angle 9^{\circ}13'N$ 700 " to a hole at Puuakamailii

- $\angle 0^{\circ}1'N$ 1840 " to top of ridge called Hamatrou
- $\angle 4^{\circ}30'E$ 2065 " crossing a gully and over a ridge to a
 hole on side of hill, a trench of stone
- $\angle 24^{\circ}41'E$ 841 " to two mile stone on south side of Govern-
 ment Road from whence the following places bear a sharp
 Peak called Kalo on ridge back of Kahaulepu $\angle 72^{\circ}56'E$
 the top of Puukolo on this boundary $\angle 3^{\circ}40'N$, the highest
 peak of Keiluke $\angle 9^{\circ}30'N$, thence from two mile stone
- $\angle 19^{\circ}35'N$ 5380 Links across flat to the top of a red hill
 called Kavalali at Kahirahina ridge
- $\angle 12^{\circ}45'E$ 1830 " to the top of a red bluff
- $\angle 55^{\circ}0'N$ 890 " along ridge from red bluff
- $\angle 49^{\circ}45'N$ 940 " along said ridge
